

## MayBell Developments Initial Application Form

This form helps MayBell staff determine whether applicants meet the minimum eligibility criteria for transitional housing at Lilium Village. Completing this form does not guarantee housing but provides the necessary information to assess if your application can move forward to the next stage.

### Minimum Eligibility Requirements

To be considered for the Lilium Village Residential Program, applicants must meet **all** of the following criteria:

- At least one member of the household must be 16 years or older and able to live independently
- The primary household 'leaseholder' must be:
  - a woman, who is pregnant, **and/or** has dependent children, **and/or** is actively working toward the return of dependent children to her care
- Meets the low-income guidelines set by the Saskatchewan Household Income Maximum (SHIM) and have assets below the established limits (proof of income and assets required later in the process; see Household Income Maximums on page 3 for reference)
- Each member of the household must be a Canadian citizen, **or** has made an application for status as a permanent resident under the *Immigration and Refugee Protection Act* (Canada) **or** has made a claim for refugee protection under the *Immigration and Refugee Protection Act* (Canada) **and** no removal order has become enforceable against any member of the household
- Does not own any residential property that could serve as suitable, safe, year-round housing
- Is capable of independent living and able to care for herself and her children without significant personal or medical support
- Is willing to participate in the program's community-based, goal-oriented structure, follow house policies and safety expectations, and engage respectfully in a community guided by Christian values (participation in faith activities is optional)
- Does not pose a safety risk to other residents, staff, or the community
